I hereby execute and deliver this Waiver and Release to induce RCYBE and or the School of the RCYBE to permit me and my child to participate in the Activities. I further agree that if, despite this release, I, or anyone on behalf of myself or my child make a claim against any of the Releasees above,

I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE OR COSTS ANY MAY INCUR AS THE RESULT OF ANY SUCH CLAIM.

I HEREBY IRREVOCABLY WAIVE ANY AND ALL RIGHTS I MAY HAVE TO A TRIAL BY JURY IN ANY ACTION, PROCEEDING OR CLAIM OF ANY NATURE RELATING TO THE ACTIVITIES. I ACKNOWLEDGE THAT THE FOREGOING WAIVER IS KNOWING AND VOLUNTARY.

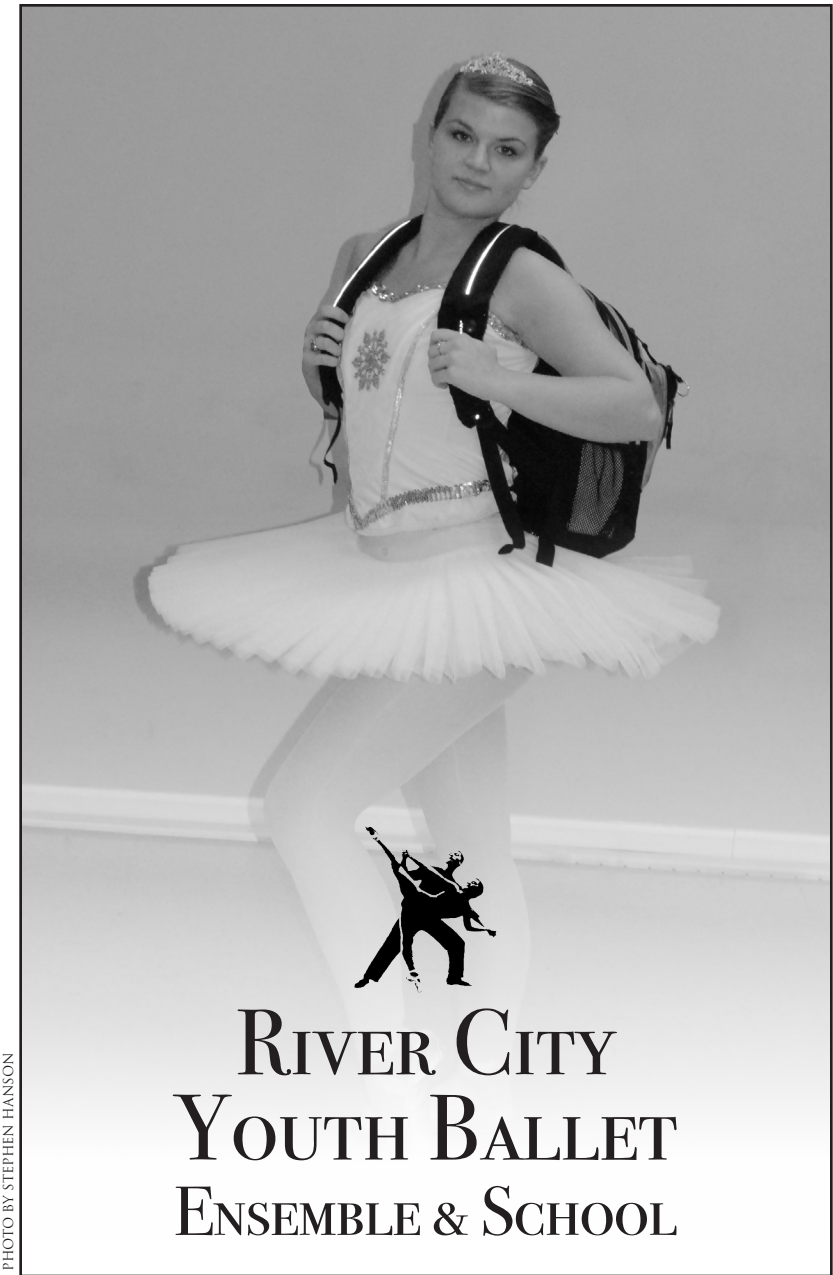
